Bangladesh Regional Project Conduct office of Korea Supreme Prosecutor's Office(SPO) invites qualified firms to express their interest in an International Competitive Bid to provide a service for BPR consulting and system construction services for Bangladesh narcotics control administrative capability reinforcement project.

This project is a public cooperation project between SPO and KOICA. SPO is the subject of this announcement, contract and project performance. But in relation to bidding, follow the provision of KOICA

1. Description of Bidding

- 1) Bid Title: Selection of the service provider of "BPR consulting and system construction project" for "Bangladesh narcotics control administrative capability reinforcement project"
- 2) Work scope: BPR consulting and Narcotics control information system build-up, support equipment and investigation equipment and invitational workshop (About detail of service range, see attached document "request for proposal")
- 3) Contract Period: 20 months from the contract date
- 4) Estimated budget: Approx. US\$ 2,608,000

2. Bid Type : International Urgent Competitive Bidding

3. Selection of successful bidder (Negotiated Agreement)

Only those who score over 85% in the evaluation of the technical proposal can qualify for the selection of the successful bidder. The one who gets the highest score combining the technical proposal (90%) and the bid price (10%) will be a priority negotiator.

<p>Qualification (Korean company)</p>	<ul style="list-style-type: none"> - By following the regulation of 'the lowest limit of the amount of eligible participation by software entrepreneur of major company'; (Ministry of Science, ICT and Future Planning notification No. 2016-93), software companies with sales of more than 800,000,000,000 KRW(Korean won) cannot participate in bidding - This project is less than 4,000,000,000 KRW(Korean won), so that major companies cannot participate in bidding except small-medium sized companies and mid-size companies that became in 5 years. This is followed by the article 2 of chapter 24(support of business participation for small-medium sized software entrepreneur) by software industry promotion law and the lowest limit of the amount of eligible participation by software entrepreneur of major company (Ministry of Science, ICT and Future Planning notification). - At the time of contract, by the chapter 14 of monopoly regulation and fair trade law, if the company is belongs to cross-shareholding limited enterprise group, it regardless of business amount(it excludes public institutions under chapter 4 by act on the management of public institutions), it cannot participate the bidding by the chapter 24,2 article 3 「 Software industry promotion law 」 and its enforcement ordinance chapter 17,6. <p>Registered in entrepreneur of information and communication followed by Chapter 14 of Information and Communication Works Business Act.</p> <p>The company should be registered as overseas construction industry (Information and Communication Works Business) followed by overseas construction promotion act.</p>

8. Tender Guarantee Bond (Bid Security) and Refund

The bidders must provide a Tender Guarantee Bond for bidding participation (cash or letter of

Guarantee) in the amount of five percent of the bid amount. In case successful bidder refuses To Sign contract without convincing reason, tender guarantee bond will be refunded to SPO.

9. Language to be used for bidding

The language using in bidding is based on Korean or English. but The standards for the interpretation of Korean and English notices are Korean.

10. Nullification of Bid

- 1) Please be sure to confirm all details about KOICA procurement and contract provisions etc. necessary for this bid beforehand and participate in the bid. The bidders are responsible for failing to confirm or understand the information
- 2) The bid will be nullified, if the bid is relevant to the regulation by the chapter 37 of KOICA regulations and implementing rules on procurement and contracting in respect of the Foreign Grant Assistance Program and "nullification of bid "by bid instructions.

11. Compliance with integrity contract: Any companies, who want to participate in this bid, should understand about KOICA special instructions for integrity agreement bidding and special condition of Integrity agreement carefully. It is presumed that all companies who participate in this bidding submitted the implementation of a memorandum of integrity agreement. For this final successful bidder must submit an implementation of a memorandum of integrity agreement at the time of signing the contract.

12. Others

- 1) Anything not specified in this bidding notice, follows KOICA regulations and implementing rules on procurement and contracting. The bidders must understand every instruction that is related to this bidding beforehand, and the responsible for the understanding is to themselves.
